The four above-captioned cause numbers have been consolidated into the lead case, Campbell v. Matthiesen, No. 23-2-25128-8. The lead and consolidated cases are in different procedural postures.

Cause No. 24-2-09698-1, Cause No. 24-2-11117-4, Cause No. 24-2-14525-7.

Complaints have been filed in Cause No. 24-2-09698-1;¹ Cause No. 24-2-11117-4;² and Cause No. 24-2-14525-7³ but have not been served on the defendants. Each cause of action has a different case schedule and trial date.⁴

Cause No. 23-2-25195-4

The Complaint in Cause No. 23-2-25195-4 is over two-hundred pages, naming numerous defendants, and lists fifteen causes of action.⁵ On May 7, 2024, before the matters were consolidated, the Court issued an order that reads: "The court intended to stay all discovery pending motions to dismiss and makes that ruling by this order."⁶ Since the stay, many of the named defendants and claims have been voluntarily or involuntarily dismissed.⁷ On September 26, 2024, the Court also granted Defendant Elizabeth Norgren's motion for summary judgment, dismissing causes of action Nos. 35, 36, 37, 38, 63, 64, 65, 74, 80, 83, 84.⁸ This matter was consolidated and assigned to the undersigned on January 30, 2025. The

1	remaining causes of action and defendants under Cause No. 23-2-25195-4 are set forth in
2	Attachment A. The current trial for this cause number is September 22, 2025. ⁹
3	Lead Case: 23-2-25128-8
4	There are two causes of action (Cause of Action No. 14 and 15) remaining under this
5	cause number. ¹⁰ There is also only one remaining named defendant. On December 3, 2024,
6	this Court signed an order staying the proceedings for 60 days. ¹¹ The trial date under the lead
7	case is currently scheduled for July 21, 2025. ¹²
8	Trial courts have the inherent authority to control and manage their calendars,
9	proceedings, and parties. ¹³ To this end, the Court issues the following:
10	 Complaints were filed in Cause Nos. 24-2-09698-1, 24-2-11117-4, and 24-2-14525- 7 nearly nine months ago, but services have not been perfected. Plaintiff must
11	effectuate service for these causes of action and file proof of service within the lead case as to these cause numbers no later than March 31, 2025 or show cause why
12	the matters should not be dismissed for lack of prosecution;
13	2. The stay orders under Cause No. 23-2-25195-4 and 23-2-25128-8 (Lead Case) are hereby lifted;
14	3. All of the case events, due dates and the trial date for all non-lead cause numbers
15	are hereby stricken; and
16	4. The Court <i>sua sponte</i> resets the trial date in the Lead Case to September 8, 2025 , and the Amended Case Schedule Order, which is filed separately, applies to the lead
17	and all of the consolidated cases
